# Opposition to Daubert Standard still growing

Last Thursday, Senate Majority Floor Leader Ron Richard announced this week would be "tort reform, court reform" week. He certainly fulfilled that promise. The Senate debated bills dealing with The English Rule, collateral source rule, medical malpractice noneconomic

damages, and the expert wit-

ness standard this week. Every bill saw members of the Senate standing up to defend the 7th amendment right to a jury trial. Only the <u>medical malpractice bill</u> passed, and that was after significant amendments.

The bulk of the momentum from opponents of the right to a trial by jury is on the expert witness standard. Only 9 states have passed rules of evidence that model the Federal Rules of Evidence 702-705 other states follow the Daubert standard but only as a court-made standard for complex cases or novel scientific ideas. Implementing a Daubert standard for all cases in Missouri Courts would be an unreasonable burden on non-tort cases like family law and criminal cases. It would also greatly increase the cost of minor auto accidents. MATA is not the only group opposed to this change. The AFL-CIO, the Railroad Employees Union, the Sheetmetal Workers and other labor groups are very concerned about how this new standard could be implemented in the workers' compensation arena. Advocates for victims of domestic violence have spoken out about how the increased cost and reporting requirements would affect adult abuse and child custody cases. Additionally, many circuit judges have contacted their Senators to express concerns over the lack of judicial resources to deal with the increased workload. The opposition keeps growing, and we are hopeful that it will make an impact. If you have not already done so, please contact your State Senator today and ask them to vote against and speak out against SB 233.

Wednesday was MATA Women's Caucus Lobby Day. Thank you to everyone who came out to Jefferson City. The day was spent working on the Daubert bill as well as a few less urgent issues. After working in the Capital for several hours, the group met up with legislators and judges at a local restaurant for a happy hour. It was a very good day of networking and lobbying.
